- 14. Chapter Membership List: Previously requested by certain Chapter members, not planning on reprinting hard-copy list
 - More to follow on this discussion
 - Teach / provide gouge to Chapter membership how to search via National to contact other Shipmates
 - If printing can be done economically, we can discuss further (need POC to do the leg work / print a "nice" document)
 - Discussed posting of a .pdf version of the list in a "hidden" area of our Chapter's web-site. Various reasons the Chapter President does not want to do this:
 - a. Even though it's in a "hidden" area, "bad guys" might / can still get to it since our Chapter's web-site is an open (i.e. not password protected) site
 - b. Our Chapter's membership personal information is simply that PERSONAL. I do not want to risk publicizing it and having the potential for misuse / abuse by non-USNA entities.



- c. National houses all of our information behind a firewall, if any member of our Chapter requests contact information for any other member of our Chapter, and if that individual cannot locate that information via National then a request can be sent to the Chapter President of VP for said information.

 - The most recent Shipmate you received was a "special" issue the Sept / Oct edition will have our recent submission
