 - Picnic previously discussed to keep it in July @ Tilles. Josh Gann volunteered to head the effort. Better to start planning early we need to place the deposit w/ the Park to secure our pavilion.

 - 1. Details to follow when STL FC follows-up.
- 5. Winter Meet & Greet vs. Dark Ages? Agreed Dave & Raese are POCs & will get the word out soon. Suggestions for location? Chapter treasury to fund an hour or 2 of the event (or say \$300 total?) and the rest on each attendee.

 - Josh Gann to approach Llewellyn's and report ASAP
 - Dave & Ted contacted BPV as alternate LZ and check availability (BPV is researching and will let us know).
 - Suggest inviting the Parents' Club, possibly GSLHF, etc.
 - Board decision to have a meet & greet vs. formal Dark Ages for 2016 (restated, there will be no "formal" Dark Ages Party for 2016).
- 6. Memorial Day: Mike again has the floor, what we need is a new Chapter POC (more recent grad) that is rooted in STL to (hopefully) take the reins & press on for foreseeable future. Suggestions for POC? We are also meeting w/ the other Chapters (USMA / USAFA) to get total buy-in from all Academies:

 - Dave has contacted Terry Councilor to see if Mr. Dierberg (from his church) will donate or otherwise discount the cost of the wreaths & ribbons (Terry replied, not sure if this is now an option, more to follow).
 - Dave to send email to Mike Dunham & other Academies to get most up to date / accurate version of program via electrons; then will save for future years (TBD @ time of these minutes).
 - Majority of program will remain year to year; then guest speaker info, etc. will be added as an insert (easier for printing, etc.).
 - Send Chapter email for volunteer to lead for next 5 or so years (Dave will send after announcing Meet & Greet gouge).
- 7. Picnic: now we need a volunteer... Josh Gann has stepped up!
 - Deposit / secure Skow Shelter (done)



- Food, Drink, Coolers (ice) Josh has the ball / others to assist
- Fans, radio, etc. Josh has lead / others to assist

 - Throw a reminder to Chapter that the annual dues pays for the picnic, funds our annual / charitable donation, pays for Memorial Day expenses, partially pays for Meet & Greet, etc.
